CGC is the parent company of Capital Research and Management Company ("CRMC"). CRMC is a U.S.-based investment management company that manages the American Funds family of mutual funds. CRMC manages equity assets for various investment companies through three divisions, Capital Research Global Investors, Capital International Investors and Capital World Investors. CRMC in turn is the parent company of Capital Group International, Inc. ("CGII"), which in turn is the parent company of five investment management companies ("CGII management companies"): Capital Guardian Trust Company ("CGTC"), Capital International, Inc. ("CIIInc"), Capital International Limited ("CIL"), Capital International Sàrl ("CISA") and Capital International K.K. ("CIKK"). The CGII management companies primarily serve as investment managers to institutional clients.

Neither CGC nor any of its affiliates own shares of UCB for its own account. Rather, the shares reported on this Notification are owned by accounts under the discretionary investment management of one or more of the investment management companies described above.

CRMC manages the American Funds family of mutual funds. CRMC (being the investment adviser to funds) has an interest in 19,402,911 shares (9.975% of total voting rights). Holdings of the CGII management companies are as follows: CGTC – 3,558 shares (0.002% of voting rights), CIL – 1,539 shares (0.001% of voting rights), CIIInc – 2,208 shares (0.001% of voting rights) and CISA – 2,455 shares (0.001% of voting rights). As CGII is the parent of the CGII management companies, CGII has an interest in 9,760 shares (0.005% of total voting rights).
